Intellectual Property

13. Any intellectual property created or developed by Subcontractor in connection with the services provided under this Agreement shall be the property of the Client. Subcontractor hereby assigns all right, title, and interest in such intellectual property to the Client.

Changes in Scope of Work

14. Any changes to the scope of work must be agreed upon in writing by both parties. Client shall have the right to make changes to the scope of work at any time upon written notice to Subcontractor.

Limitation of Liability

15. Subcontractor shall not be liable to Client for any indirect, special, consequential, or punitive damages arising out of or in connection with the services provided under this Agreement, regardless of the cause of action or legal theory. Force Majeure

Notice

17. Any notice required or permitted to be given under this Agreement shall be in writing and shall be deemed effective upon personal delivery, or upon receipt of certified or registered mail, or upon receipt of confirmed facsimile transmission, or upon receipt of confirmed electronic mail transmission.

Assignment

18. Subcontractor shall not assign or transfer any of its rights or obligations under this Agreement without the prior written consent of the Client.

Survival

19. Any provisions of this Agreement which by their nature extend beyond the termination of this Agreement shall survive such termination.
