In the event that the Contract is terminated for any reason, Subcontractor shall be entitled to payment for all work completed prior to the termination date.

- 3. Insurance: Subcontractor shall maintain, at its own expense, insurance coverage as required by law and as reasonably requested by General Contractor, including workers' compensation insurance, general liability insurance, and automobile liability insurance. Subcontractor shall provide General Contractor with certificates of insurance evidencing such coverage.
- 4. Indemnification: Subcontractor shall indemnify, defend, and hold harmless General Contractor and its officers, directors, employees, agents, and affiliates from and against any and all claims, damages, losses, liabilities, and expenses (including reasonable attorneys' fees and court costs) arising out of or in connection with Subcontractor's performance of the Work, including any breach of this Agreement.
- 5. **Termination**: General Contractor may terminate this Agreement for any reason upon written notice to Subcontractor. In the event of termination, Subcontractor shall immediately cease work and shall be entitled to payment only for work completed prior to the termination date.
- 6. **Confidentiality**: Subcontractor shall keep confidential all information and documents received from General Contractor or the Client relating to the Work or the Contract, and shall not disclose such information or documents to any third party without General Contractor's prior written consent.
- 7. **Governing Law and Venue**: This Agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_\_. Any legal action arising out of or in connection with this Agreement shall be brought in the state or federal courts located in \_\_\_\_\_\_. and each party hereby submits to the jurisdiction of such courts.
- 8. **Change Orders**: General Contractor may request changes to the scope of Work by issuing a written change order to Subcontractor. Any change order must be approved in writing by both parties and will be considered an amendment to this Agreement.
- 9. **Safety**: Subcontractor shall comply with all applicable safety regulations and requirements related to the Work, and shall take all necessary precautions to ensure the



- safety of its employees, General Contractor's employees, and any other persons who may be affected by the Work.
- 10. **Warranty**: Subcontractor warrants that the Work shall be free from defects in materials and workmanship for a period of [X years/months] from the date of substantial completion. If any defects are discovered during the warranty period, Subcontractor shall promptly correct such defects at its own expense.
- 11. **Subcontracting**: Subcontractor shall not subcontract any portion of the Work without the prior written consent of General Contractor.
- 12. **Notices**: Any notices required or permitted under this Agreement shall be in writing and delivered personally, by certified mail, or by overnight courier to the addresses listed in the preamble to this Agreement.
- 13. **Assignment and Binding Effect**: This Agreement may not be assigned by either party without the prior written consent of the other party. This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
- 14. **Force Majeure**: Neither party shall be liable for any delay or failure to perform its obligations under this Agreement to the extent that such delay or failure is caused by events beyond its reasonable control, including but not limited to acts of God, war, terrorism, fire, flood, or other natural disasters.
- 15. **No Waiver**: The failure of either party to enforce any provision of this Agreement shall not be deemed a waiver of such provision or of the right to enforce such provision in the future.
- 16. Counterparts: This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
- 17. **Entire Agreement**: This Agreement constitutes the entire agreement between the parties with respect to the Work and supersedes all prior or contemporaneous agreements and understandings, whether written or oral.
