- 5. **Modification**. This Agreement may not be modified or amended except in writing signed by both parties.
- 6. **Prepayment**. Debtor may prepay any amount owed under this Agreement at any time without penalty.
- 7. **Termination**. This Agreement may be terminated by either party upon written notice if the other party breaches any provision of this Agreement.
- 8. **Confidentiality**. All information and communications between the parties relating to this Agreement shall be kept confidential and shall not be disclosed to any third party without the prior written consent of the other party, except as required by law.
- 9. **Security Interest**. Creditor shall have a security interest in any goods or property sold or delivered to Debtor until the Debt is fully paid. Debtor authorizes Creditor to file any financing statements or other documents necessary to perfect this security interest.
- 10. **No Waiver**. The failure of either party to insist on strict performance of any provision of this Agreement shall not be deemed a waiver of any right or remedy that the party may have, nor shall it be deemed a waiver of any subsequent breach of the same or any other provision.
- 11. **Assignment**. Neither party may assign this Agreement without the prior written consent of the other party.
- 12. **Notices**. Any notice or other communication required or permitted under this Agreement shall be in writing and shall be deemed given when delivered personally, sent by facsimile or electronic mail, or deposited in the United States mail, postage prepaid, and addressed to the parties at the addresses set forth in this Agreement or to such other addresses as either party may designate by written notice to the other.

- 14. **Headings**. The headings in this Agreement are for convenience only and shall not affect the interpretation of this Agreement.
- 15. **Counterparts**. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
- 16. **Entire Agreement**. This Agreement contains the entire understanding of the parties and supersedes all prior or contemporaneous negotiations, understandings, or agreements, whether written or oral.
- 17. **Governing Law**. This Agreement shall be governed by and construed in accordance with the laws of the State of \_\_\_\_\_\_. Any dispute arising under this Agreement shall be resolved in accordance with the dispute resolution procedures set forth below.
