# **Governing Law**

#### **Amendments**

## **Counterparts**

#### **Termination for Convenience**

#### **Termination for Cause**

12. Either party may terminate this Agreement for cause upon written notice to the other party in the event of a material breach of this Agreement by the other party. #### Non-Solicitation
