**Access to Property**: Client shall provide Service Provider with access to the Property during the scheduled Service times. If access is not provided, Service Provider shall not be responsible for any damage or delays in performing the Services.

**Equipment and Supplies:** Service Provider shall provide all equipment and supplies necessary to perform the Services. Client shall not be responsible for any expenses related to the equipment or supplies.

**Changes to Services:** Client may request changes to the Services by providing written notice to Service Provider. Service Provider shall have the right to adjust the fees for the Services based on the changes requested.

**Non-Solicitation:** During the term of this Agreement and for a period of [NUMBER] months following termination, Client agrees not to hire or solicit any employees of Service Provider.

**Confidentiality:** Service Provider agrees to keep all information related to the Services and the Client confidential and shall not disclose such information to any third party without the Client's prior written consent.



**Non-Exclusivity:** Client may engage other lawn care service providers in addition to Service Provider.

**Force Majeure:** Neither Party shall be liable for any delay or failure to perform any obligations under this Agreement if such delay or failure is caused by events beyond its reasonable control, including but not limited to acts of God, war, riot, terrorism, pandemic, and governmental regulations.

**Waiver:** Any waiver of a breach of any provision of this Agreement shall not operate or be construed as a waiver of any subsequent breach of the same or any other provision.

**Indemnification:** Service Provider shall indemnify and hold harmless Client, its officers, employees, and agents from any and all claims, damages, losses, or expenses arising out of or in connection with Service Provider's performance of the Services.

**Insurance:** Service Provider shall maintain the following insurance coverage:
