perform the services described in Exhibit A. The Client shall be responsible for ensuring that all information and data provided to the Bookkeeper is complete and accurate.

## Confidentiality:

The Bookkeeper shall maintain the confidentiality of the Client's financial information and shall not disclose such information to any third party without the prior written consent of the Client. The Bookkeeper shall use the Client's financial information only for the purpose of performing the services described in Exhibit A attached hereto.

### Indemnification:

The Client shall indemnify and hold harmless the Bookkeeper, its officers, directors, employees, and agents, from any and all claims, damages, and expenses (including reasonable attorneys' fees) arising out of or in connection with the Bookkeeper's performance of services under this Agreement.
