Under state law, any violation of this agreement by the Tenant will immediately terminate the rental period. Upon failure to vacate the premises at the end of the rental period, the Tenant waives all rights to process. The tenant will vacate the premises after the expiration of this agreement.
- 15. **MAINTENANCE AND REPAIRS**. The Tenant is responsible for maintaining the Premises in a clean, well-organized, and ready-to-rent condition and for using the Premises legally and safely. When this Agreement expires, the Tenant is responsible for leaving the Premises in a habitable condition for the next tenant, as determined by the Landlord. Maintenance and repairs will be the Tenant's responsibility if the premises remain in a less-than-satisfactory condition. Before refunding the Security Deposit, the tenant agrees that the Landlord will deduct the cost of repairs if there are damages to the Premises or its furnishings.
- 16. **TRASH**. All waste generated during the Lease Term must be disposed of in accordance with the landlord's strict instructions and directions.
- 17. **QUIET ENJOYMENT.** The Tenant and neighbors shall enjoy each other's company in a guiet and respectful manner. Tenants are expected to behave



civilly and be good neighbors with any residents of the immediate area. If large gatherings or parties create a disturbance in the area, this Agreement will be terminated immediately.

- 18. **LANDLORD'S LIABILITY.** Tenant and guests hereby indemnify and hold harmless the Landlord from any and all claims of personal injury or property damage. Landlord's property insurance does not cover Tenant's personal property. In order to provide such coverage, the tenant must purchase their own insurance for their guests.
- 19. **ATTORNEY'S FEES**. It is the Tenant's responsibility to cover all reasonable costs, attorney's fees, and expenses that the Landlord may incur in enforcing this agreement.
- 20. **USE OF PREMISES**. The Premises shall only be used by the Tenant for residential purposes. Tenants are not to engage in any commercial activity or sell products or services on the Premises.
- 21. **ILLEGAL ACTIVITY.** The Tenant shall only use the premises for legal purposes. The agreement will be immediately terminated without refund of pre-paid rent if any other use is discovered, including illicit drug use, verbal abuse, physical abuse, or illegal sexual behavior.
- 22. **POSSESSIONS**. Personal belongings left on the property are not the responsibility of the landlord. An item should be returned to a Tenant by the Landlord using all reasonable efforts. If claims are not made within the required timeframe or two (2) weeks, the Landlord may keep the items for personal use or sale.
- 23. **GOVERNING LAW**. This Agreement will be governed and interpreted by the laws of the jurisdiction of the Premises.
