MEDICAL POWER OF ATTORNEY IMPORTANT NOTICE

Please review the following information carefully before signing this document. Seek guidance from a healthcare professional or attorney if you have any questions or concerns about the terms.

By signing this document, you are authorizing the person you designate as your agent to make medical decisions on your behalf. This includes decisions regarding medical treatments, procedures, diagnoses, and the treatment of both mental and physical conditions. Your agent will have the authority to make decisions just as you would if you were able, including consenting to, refusing, or withdrawing life-sustaining treatment. Therefore, it is crucial to choose someone you trust and who understands your healthcare preferences.

You retain the right to make your healthcare decisions as long as you are mentally competent. Your agent will only act on your behalf if your physician determines that you are no longer able to make medical decisions.

Your chosen agent must be at least eighteen years old and someone you trust with your healthcare. They will not be held liable for decisions made in good faith. Ensure that your agent is willing to take on this role and discuss your medical preferences with them. You may also appoint a backup agent who is aware of your preferences and over eighteen years old.

You have the right to revoke this document at any time while you are still mentally competent. You can do so by informing your medical provider and agent verbally or in writing. Executing another power of attorney will revoke this one.

This document must be signed in the presence of a notary public or two independent witnesses who are over eighteen and competent. They cannot be your agent or related to your agent.
