- 8. **Limitation of Liability**. The Location Owner shall not be liable to the Production Company or any third party for any loss, damage, or injury arising out of or in connection with the Production Company's use of the Location.
- 9. **Termination**. Either party may terminate this Agreement upon written notice to the other party. In the event of termination, the Production Company shall immediately cease all use of the Location.
- 10. **Entire Agreement.** This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, understandings, and agreements between the parties with respect to the subject matter hereof.



- 11. **Governing Law**. This Agreement shall be governed by and construed in accordance with the laws of the State of [Insert State].
