The recipient further warrants that it will exercise reasonable care and at a minimum, ordinary precautions to protect its own confidential information. If Recipient is not an individual, Recipient certifies that such employees have previously signed a copy of this Agreement and agrees that Recipient shall only disclose Confidential Information to those of its employees who need to know such information.
- **III. Survival**. All communications between the parties shall be in accordance with this Agreement. The recipient is aware that its responsibilities under Section/paragraph 2 ("Non-Disclosure and Non-Use Obligations") continue even after any other contractual obligations have ended. Recipient shall promptly deliver all documents and other materials provided by Releasor to Releasor upon the termination of any relationship between the parties, without retaining any copies.
