5. All personal property, trash, and other items not present in the venue when Renter took control shall be removed by Renter.

When Renter completes his/her obligations under (4) and (5) above, the Owner will return the security deposit to the Renter, minus any amounts deemed necessary to repair any damage caused to the venue by Renter, Renter's associates, guests, invitees, contractors, and anyone else who enters the venue during the rental period, whether or not they do so with Renter's knowledge.

7. Should Renter fail to pay the balance due within the agreed time period, interest will accrue at the rate of \_\_\_\_\_% per year until the balance is paid. A renter shall also be responsible for any legal fees, court costs, and other collection expenses incurred by the owner.

When Renter is in control of the venue, Renter will be liable for any physical damages, legal actions, reputation damage, or loss of business opportunities the Owner may suffer as a result of the actions of Renter or any of Renter's guests, and shall indemnify and hold harmless the Owner against any and all legal actions that may result from Renter using the venue.
