Lessee to Maintain Premises.

The Lessee agrees to keep and maintain the premises in a good state of repair at all times. At the expense of Lessee, Lessee will promptly repair any damage to the premises caused by Lessee or any agent, employee, customer, guest or invitee of Lessee. Lessee shall not deface or damage the premises in any way. No structural changes or other alterations will be made to the premises without prior written consent from Lessor. At the end of the term of this Agreement, or at any earlier termination thereof, Lessee will return the premises in as good a condition as they were at the beginning at the term of this lease, except for ordinary wear and tear.

Janitorial Service.

Lessor may provide janitorial and cleaning services to the premises on a discretionary basis.

take absolute possession of the premises immediately or at any time thereafter, without further notice or demand, without forfeiting the rent or covenants to be performed by Lessee, and without reentry working a forfeiture of these rents and covenants. Lessee for the full term of this lease. The Lessor may, in such circumstances, lease or sublet the premises, or any part thereof, for such terms and conditions, rent, and term as Lessor chooses, and, after subtracting the rent actually collected by Lessor from subletting from the rent that Lessee is required to pay under this lease, collect any balance due on the rent.

Assignment and Subletting.

A sublet or assignment of the premises by Lessee shall not be permitted without prior written permission from Lessor, which shall not be unreasonably withheld.

Damages to or Destruction of Premises.

It is Lessor's responsibility to repair and restore the premises as soon as reasonably practicable after such damage if it is partially or totally destroyed or damaged by fire or other hazards. Should, however, the premises become completely destroyed or so damaged that they cannot be reasonably used by Lessee, then the Lessor may terminate this lease by serving a written notice of the termination to Lessee.

Severability.

If any provision of this Agreement is invalid, it will not and shall not affect the validity of any other provision. Upon the invalidation of any provision of this Agreement, the parties agree that the remaining provisions shall be considered in full force and effect as if they had been executed by both parties following the invalidation.

No Waiver.

It shall not be construed as waiving any of the terms and conditions of this Agreement if either party fails to insist that any of the terms and conditions of this Agreement be performed or if any breach is waived, and the same terms and conditions shall remain in full force and effect as if no forbearance or waiver had occurred.

Mandatory Arbitration:

Any dispute arising under this Agreement shall be resolved by binding arbitration between the parties. If the parties cannot agree on an arbitrator, each party shall select one arbitrator and both arbitrators shall then decide a third. The third arbitrator so selected shall arbitrate said dispute. Arbitration shall be governed by the rules then in effect of the American Arbitration Association.

Assignment of Rights.

Under this Agreement, each party's rights are personal to that party and may not be assigned or transferred to any other person, firm, corporation, or other entity without the prior, express, and written consent of the other party.
